

2022 Summer Undergraduate Fellows

During the Summer of 2022, over 400 Stanford students engaged in immersive service opportunities with organizations located around the world. See a map (<http://cardinalquarterfellows.cardinalservice.org>) illustrating the organizations our fellows worked with during the summer.

The students listed below were supported or co-sponsored by the Haas Center for Public Service's Undergraduate Fellowships Program.

Advancing Gender Equity Fellows

The Advancing Gender Equity Fellowship is a joint program with the Women's Community Center and enables students to learn about gender, diversity, and social justice through a summer practicum with a nonprofit organization or government agency addressing social, political, or economic issues affecting women.

- **Crystal Chen, '24 (Human Biology); Women's Cancer Resource Organization, Berkeley, CA.** Crystal interned at Women's Cancer Resource Center in Berkeley, a nonprofit organization that provides financial, emotional, and practical support and resources for women and non-binary people with cancer or are cancer survivors. She compiled local social support resources for clients, connected clients to existing WCRC programs, and helped reimagine volunteer recruitment, engagement, and development.
- **Lora Supandi, '23 (International Relations); Remote.** Lora Supandi interned for the Ostara Initiative, which is the umbrella organization that unites the Minnesota Prison Doula Project and Alabama Birth Project. Despite being in separate states with different laws, the three organizations march toward the same goal: to ensure reproductive rights and adequate care for incarcerated individuals, especially childbearing mothers. The Ostara Initiative is run by women and justice-impacted individuals, such as prison doulas and women who have experienced childbirth in prison. Lora assisted the Ostara Initiative in writing grants, conducting research, and pursuing further legislative steps to implement policy.

African Service Fellows

The African Service Fellowship is a joint program with the Center for African Studies supporting students' work on social and economic issues in Africa.

- **Temiloluwa Adeyemo, '23 (Human Biology); Asido Foundation, Ibadan, Oyo State, Nigeria.** Temiloluwa interned at Asido Foundation, a mental health research and advocacy nonprofit that looks to advance the mental wellness of Nigerians. Temi authored a literature review on Community Resilience in Nigeria during COVID-19, while working as a guest host on Mindset, the organization's radio program which spreads awareness and eliminates stigma about mental health.
- **Meghan Jin, '24 (Human Biology); PATH, Remote.** Meghan interned at PATH, a global health nonprofit that aims to accelerate health equity through various partnerships with public institutions,

grassroots groups, and local communities. She worked with the team in Uganda to advance self-testing for HIV and COVID-19 in the region, including conducting research on COVID-19 knowledge among key populations.

- **Abhinav Kumar, '24 (Biomedical Computation); HERI Kenya, Ukunda, Kenya (Remote).** Abhi worked with HERI Kenya, a nonprofit organization that promotes environmental and community health in Kenya through education, research, and advocacy for policy change. His primary project was to design, conduct, and analyze a KAP (Knowledge, Attitudes, and Practices) survey on waste management and mosquito-borne viruses. His analysis will help inform future educational interventions and clean up efforts at HERI Kenya.
- **Malisha Lutchmeea, '25 (Undeclared); EducationUSA, Port Louis, Mauritius.** Malisha interned at EducationUSA through the U.S embassy in Mauritius where she worked on an education access project to support low-income students in her home country. She guided students applying to U.S universities through workshops on the SAT test-taking strategies, essay-writing, and the general application process and her work culminated in an application guide that will be used by prospective applicants.
- **Iddah Mlauzi, '25 (Undeclared); Uncommon.org, Harare, Zimbabwe.** Iddah interned at Uncommon.org, a nonprofit organization in Zimbabwe that is dedicated to helping unemployed, young adults in low-income communities launch their careers in the technology industry. She led workshops on ethics in technology and facilitation best practices and helped reimagine the fundraising model.
- **Jackline Wambua, '25 (Undeclared); Association of the Physically Disabled of Kenya, Nairobi, Kenya.** Jackline interned at the Association for the Physically Disabled of Kenya a non-profit organization she admires for its commitment to improving the lives of persons with disabilities through advocating for an inclusive society, provision of rehabilitation services, economical empowerment, and advocating for the rights of persons with disability. Jackline provided logistical support and supported the media personnel in capturing stories and updating content on their social media platforms.

Alexander Tung Memorial Fellows

Through the Alexander Tung Memorial Fellowship, students can explore the use of science and technology for the benefit of society at large.

- **Anudeep Golla, '24 (Computer Science); Accelerated Cure Project, Broomfield, CO.** Anudeep interned at Accelerated Cure Project (ACP), a nonprofit organization whose mission is to accelerate efforts toward a cure for multiple sclerosis by rapidly advancing research that determines its causes and mechanisms. He researched the most valuable features of peer-powered research networks and collected data regarding the most pressing research community needs of MS patients, and set out to implement these components into the iConquerMS research platform.
- **Hiran Dewar, '23 (Biomedical Computation); Accountability Counsel, San Francisco, CA.** Hiran interned at Accountability Counsel, a nonprofit that works on human rights through gaining accountability for harm perpetrated by projects financed by international development banks. She

created an environmental sensor that monitors air quality without internet or electricity for communities to easily document air pollution caused by development projects.

Andrea Naomi Leiderman Fellow

The Andrea Naomi Leiderman Fellowship supports undergraduate students conducting research related to underserved youth in California.

- **Alysson Farris, '23 (Public Policy); SPARK Lab, Stanford, CA.** Alysson interned for Spark Lab, which focuses on early childhood education, on their partnership with San Francisco United School District. She worked on processing and documentation of new assessment and enrollment data.

Bay Area Climate Justice Fellowships with PCJ in the Bay

Fellows work with a partner in the Partnership for Climate Justice in the Bay initiative to help build climate resilience and an equitable transition to clean energy in the Bay Area, with an environmental justice lens.

- **Veronica Ayala, '22 (Science, Technology, and Society); Communities for a Better Environment, Richmond, CA.** Veronica drafted a policy brief regarding the different policies enacted to prevent fossil fuel infrastructure development and to phase out existing fossil fuel infrastructure.
- **Bryana Gastelum '24 (Undeclared); Communities for a Better Environment, Richmond, CA.** Bryana created a presentation discussing the history of public and private funds between Chevron and the City of Richmond. The objective of this presentation was to build a foundation for discussions involving Just Transition funds in Richmond.
- **Bless Romo '22 (Earth Systems); North Fair Oaks Community Alliance, North Fair Oaks, CA.** Bless edited NFOCA's website and created fliers for the organization's workshops for the community. Bless also drafted various grant proposals.
- **Zunarah Ahmad '23 (Earth Systems): Climate Resilient Communities, Palo Alto, CA.**
- **Vel Senthil '25 (Undeclared); Thrive Alliance, Redwood City, CA.** Vel helped with planning and organizing a Climate Summit that Thrive Alliance will be holding in the fall of 2022. Vel helped design the organization's webpage and banner that advertised for the Summit.

Black Diaspora Fellow

The Black Diaspora Fellowship affords students the opportunity to serve in organizations that work on issues central to achieving justice and equity for Black communities.

- **Hodan Farah, '23 (Biology); Muslim Wellness Foundation, Remote.** Hodan interned at the Muslim Wellness Foundation (MWF), a Black Muslim organization that works to de-stigmatize mental health issues in Muslim communities, and provide resources, knowledge and more to Muslim communities regarding mental health and wellness. She did web development for the organization and in her final project, created a Central Brochure for their website and donors which was a comprehensive

story of the MWF including origin story, values, MWF rebrand, founder, donor, and fellow spotlights, and more.

Chicanx/Latinx Communities Fellow

The Chicanx/Latinx Communities Fellowship enables students to engage with Chicanx/Latinx communities and apply their experience, academic pursuits, and leadership to address issues of race, social justice, equity, inclusion, and artistic expressive history in movements for social change centered on the Chicanx/Latinx experience.

- **Myrka Cruz, '25 (Undeclared); Freedom for Immigrants, Remote.** Myrka interned at Freedom for Immigrants, a nonprofit organization devoted to abolishing immigration detention and monitoring abuses through a national hotline. She updated the COVID-19 map, drafted a report on detention centers in Ohio, and helped launch FFI's National Detention Facility Resource Directory, which had been put on hold for several years.

Civic Fellows

- **Hannah Griswold, '25 (Undeclared); Mending Matters, San Diego, CA.** Hannah interned for Mending Matters, a nonprofit organization that provides mental health support services to students in California schools. She created a curriculum to educate 9th and 10th grade students on well-being and mental health, with the intention of preventing mental health struggles.
- **Michael Murray, '25 (Undeclared); Rosedale Freedom Project, Rosedale, MS.** Michael served as a Teacher-Advisor with the Rosedale Freedom Project, a nonprofit summer school program for middle and high school students living in the Mississippi Delta. He taught 6th and 7th grade math and reading, and led the students on field trips to Civil Rights museums and sites.
- **Matthew Yekell, '25 (Undeclared); Covenant Community Capital, Houston, TX.** Matthew interned at Covenant Community Capital, a nonprofit organization focused on expanding rates of home ownership in Houston, Texas. Matthew helped the organization reduce the time spent on repetitive tasks through the use of automation.

CS+Social Good Summer Fellows

CS+Social Good Fellows work with organizations using technology to address social issues.

- **Elias Applebaum, '25 (Undeclared); CareerVillage.org, Remote.** Elias interned at CareerVillage.org, a non-profit organization that democratizes access to career information and advice by connecting students with professionals to answer career questions on CareerVillage.org, building a massive open-access reference source that career-oriented students can access anytime, anywhere. Working with the dev team, he implemented search engine optimization (SEO) objectives that will help attract more students and professionals to the CareerVillage community and created a plan for team members to more effectively integrate machine learning into the “tags” functionality of the website.

- **Isaac Bevers, '23 (Symbolic Systems); humanID, Remote.** Isaac interned at humanID, a start-up that provides a modular login system that can be integrated with other platforms that protects user data and makes it prohibitively costly to create bot accounts. He developed a dashboard that provides a live estimate of bot activity for top trends on Twitter.
- **Karina Chen, '25 (Undeclared); San Jose Mayor's Office of Technology and Innovation, San Jose, CA*.** Karina interned at the San Jose Mayor's Office of Technology and Innovation, which leverages the ingenuity of Silicon Valley to tackle city issues and improve residents' livelihoods. She primarily worked on a digital inclusion project and also contributed to projects relating to traffic safety and public health.

- **Viraj Mehta, '25 (Computer Science); humanID, Remote.** Viraj interned at humanID: Foundation for a Human Internet, a nonprofit cybersecurity organization that aims to create safer online communities by preventing bot attacks and fake accounts. Viraj worked with their software development team to enhance humanID's developer console.
- **Savannah Payne, '22 (Symbolic Systems); Edstruments, Redwood City, CA.** Savannah interned at Edstruments, a organization that provides budgeting and finance software for the unique needs of education, nonprofit, and public sector leaders. She designed application pages for their new purchasing module and designed and implemented an updated website.
- **Gayatri Devi Tarcar, '24 (Undeclared); Accountability Counsel, Remote.** Gayatri Devi interned at Accountability Counsel, a non-profit creating and storing a comprehensive database of community complaints filed with independent accountability mechanisms about the impacts of internationally financed projects. As a Product Intern, she worked alongside a team where she monitored and improved the SEO performance of the organization's website.
- **Alexander Worley, '25 (Undeclared); Every.org, San Francisco, CA.** Alexander interned at Every.org, a nonprofit organization that provides accessible giving infrastructure for a more generous world. He learned JavaScript, TypeScript, HTML, React, Git, and Vim, and he used these tools to make an example giving application which uses Every.org's API.

Donald Kennedy Public Service Fellows

Through the Donald Kennedy Public Service Fellowship, students develop and implement innovative service projects in collaboration with communities to address identified needs.

- **Faith Ajanaku, '25 (Undeclared); Riley's Way Foundation, Brooklyn, NY.** Faith interned at Riley's Way Foundation, a nonprofit that empowers young leaders to use kindness and empathy to create

meaningful connections and positive change through the following programs: Call For Kindness, Youth Leadership Retreat, and Riley's Way Council and Program. She led the mental health cohort, helped develop the alumni network, consulted young leaders, and created detailed year long guidelines and programming for the foundation.

- **Grace Barket, '23 (Public Policy); Dreamcatchers, Palo Alto, CA.** Grace interned with Dreamcatchers in Palo Alto, a nonprofit organization that provides academic and community support to middle schoolers in the Palo Alto Unified School District that come from low income backgrounds, with the aim of promoting equity in education. Grace helped orchestrate community partnerships with Dreamcatchers for the coming school year, assisted in redesigning the program's structure, and supported the Dreamcatchers summer program through various tasks.
- **Jose Davila, '24 (Undeclared); Youth Alliance For Housing (YAH), New York, NY.** Jose worked as a member of the Youth Alliance For Housing, a community organization founded on the belief that housing justice is a human right. Throughout their work, YAH stresses the intersectionality of housing issues and recognizes that housing justice is racial justice and is youth justice. Jose worked with the team to develop a website to publish various digital and print projects YAH has made since their founding, while also serving in graphic design for the organization.
- **Chrysanthe Frangos, '25 (Undeclared); Alaska Wildlife Conservation Center, Girdwood, AK.** Chrysanthe worked as a Naturalist Fellow at the Alaska Wildlife Conservation Center, a sanctuary dedicated to preserving Alaska's wildlife through conservation, education, research, and quality animal care. She developed a free, educational scavenger hunt that takes guests on a self-guided tour throughout the Center.
- **Catherine Horkay, '23 (Computer Science); Center for RISC at University of Chicago, Chicago, IL.** Catherine interned at the University of Chicago's Center for RISC - an innovation lab for radical social change. She assisted with the mutual aid project for Chicago's community utility bills and was also mentored on web development.
- **Sriya Mantena, '25 (Computer Science - Biocomputation); Stanford Children's Teen Van, Palo Alto, CA.** Sriya interned with the Stanford Children's Hospital Teen Van, a mobile clinic offering free health services to uninsured and underinsured youth in the San Francisco Bay Area. She created a survey to understand the barriers to applying for health insurance and worked to design a digital platform to empower under-resourced teens to navigate the complex Medi-Cal application process.
- **Joseph Moser, '24 (Computer Science); NYC Mesh, New York, NY.** Joseph spent his summer at NYC Mesh, a volunteer-run nonprofit which provides high-speed internet at low cost in underserved areas. Among other things, he was solely responsible for installing, maintaining, and repairing internet service for a 600-apartment low-income housing complex.
- **Dyllen Nellis, '24 (Human Centered Design and Engineering), RISC, Chicago, IL.** Dyllen interned at Radical Innovation for Social Change (RISC), a social innovation lab headed by Steven Levitt, the author of Freakonomics, that generates and implements unorthodox solutions to the world's biggest problems. She researched massive open online courses for an education project and provided user interface feedback for a mutual aid platform.

- **Anna-Katharina Preidl, '24 (Undeclared); Apples to Zucchini Cooking School, Santa Barbara, CA.** Anna-Katharina interned at Apples to Zucchini Cooking School, a non-profit organization in Santa Barbara, where she worked as a chef educator at their summer camp, teaching local children how to prepare delicious, nutritious, affordable meals made from seasonal and local ingredients. Moreover, she wrote a food science program that will be implemented at Santa Barbara and Goleta schools in January 2023.
- **Erick Rocha, '25 (Undeclared); Building Healthy Communities, Salinas, CA.** Erick interned at Building Healthy Communities East Salinas, a community-based organizations that is working to support community engagement and leadership for a healthy, safe, and thriving East Salinas and the wider Salinas Valley. He led his own project that examined under-analyzed aspects of Salinas history along with several high schoolers, facilitated staff meetings, and used previous experience to help facilitate a youth group.

Earth Systems Public Service Summer Fellows

Offered jointly with the Earth Systems Program, the Earth Systems Public Service Summer Fellowship enables students to apply what they have learned through interdisciplinary environmental studies to summer internship experiences.

- **Diana Baszucki, '24 (Undeclared); Florence Fang Community Farm, San Francisco, CA.** Diana interned at Florence Fang Community Farm, a nonprofit organization dedicated to advancing food security and food sovereignty for residents of the Bayview Neighborhood in San Francisco. She worked with the youth program there to develop lesson plans and curriculum goals for the students.
- **Alan Cuevas, '23 (Earth Systems); Bayview-Hunter's Point Community Advocates, San Francisco, CA.** Alan interned at Bayview-Hunter's Point Community Advocates, a grassroots organization working to address environmental justice issues in the vulnerable Bayview-Hunter's Point neighborhoods through community organizing, education, and direct services. He used EPA and naval documents to compile over 300 hazardous sites in the neighborhood and created a map to guide a multi-year toxic survey of the sites.
- **Lily Laughann, '23 (Earth Systems); Kounkuey Design Initiative, Los Angeles, CA.** Lily interned at Kounkuey Design Initiative, a non-profit design firm composed of urban planners, landscape architects, and community organizers that partners with under-resourced communities in Los Angeles on the design of spaces in the public sphere. Lily was involved in the research and writing of a report on gender equity in public transport as well as community engagement + observational studies for two proposed public park projects.

Education Achievement Fellows

Education Achievement Fellows engage in a summer practicum at education-focused nonprofits, foundations, or government agencies as part of a cohort in Boulder, Colorado.

- **Sachin Allums, '24 (Symbolic Systems); "I Have a Dream" Foundation, Boulder, CO.** Sachin worked at both an Elementary school and a community center planning and leading field trips and educational games for 5th-7th grade students. While in Colorado, Sachin conducted budget

analyses, attended home visits, and supported students at a college and career conference named DreamUP.

- **Ryan Esquivel, '25 (Undeclared); "I Have a Dream" Foundation, Boulder, CO.** Ryan interned at I Have a Dream Foundation-Boulder, a nonprofit organization that provides individualized social, emotional, and academic support to young people from under-resourced communities from 1st grade all the way through college. He served as a tutor for high school students working in summer credit recovery to help them be on track for graduation.
- **Lance Lee, '23 (Public Policy); ELPASO, Lafayette, CO.** Lance spent the summer with ELPASO in Colorado, a non profit organization with the goal of reducing the academic achievement gap between the hispanic and white community and creating change that will have lasting effects through many generations. He aided in the creation, conduction, and dispersion of surveys to gather information for future policy endeavors.
- **Adan Marquez, '25 (Undeclared); "I Have a Dream" Foundation, Boulder, CO.** Adan was a fellow at "I Have a Dream" Foundation, Boulder County, a nonprofit organization that helps under-resourced students from elementary until their post-secondary education; it not only provides educational services like tutoring and career advising but social and emotional support by balancing academic and social programming. Adan provided Math, Physics, and History tutoring for High School students, while serving as a mentor and planning programs for Middle School students, and facilitating a computer proficiency class for Spanish-speaking parents.
- **Shelby Whinery, '23 (Human Biology); "I Have a Dream" Foundation, Boulder, CO.** Shelby spent the summer interning with the "I Have a Dream" Foundation of Boulder County, a nonprofit organization that provides educational and instrumental support opportunities to low-income youth. During her internship, she supported first graders reading and math comprehension in a bilingual classroom, used data to analyze trends in student beliefs about academics and belonging, and greatly enjoyed field trip days with the Dreamers.

Education and Youth Development Fellows

The Education and Youth Development Fellowship supports programs addressing academic and social needs of underserved youth.

- **Mahlet Ayele, '25 (Undeclared); Council for Opportunity in Education, Washington, D.C.** Mahlet interned at the Council for Opportunity in Education, a non-profit organization dedicated to furthering educational opportunity for low-income first-generation students. She created a "How to be a Successful Intern" pamphlet for future interns at the organization, as well as writing a memo on the 2nd Chance Pell Grant, which allows incarcerated students to seek post-secondary educational programs.
- **Nora Brew, '24 (Undeclared); LifeMoves, San Jose, CA.** Nora interned at LifeMoves, an organization that provides comprehensive services to Bay Area homeless. She worked within the education department at LifeMoves, helping to put on academic summer programming for the kids at shelter locations in San Jose.

- **Ninette Calderon, '25 (Management Science and Engineering); UrbanTXT: teens in technology, Los Angeles, CA.** Ninette interned at Urban Txt: Teens in Technology, a nonprofit organization that serves to empower black and brown boys in South Central, Los Angeles. She served as a youth development and software development coach to help four students create a software and hardware product that addresses a community issue.
- **Shirley Frame, '24 (Psychology); Wise Readers to Leaders, Los Angeles, CA.** Shirley taught a classroom of K-1 students at Wise Readers to Leaders, a non-profit organization that partners with schools and community centers in LA to offer summer literacy programs for kids. As a teacher, Shirley designed and delivered curriculum to her class focusing on reading, writing, art, STEM projects, and social and emotional learning.
- **Kelly Harvell, '24 (Bioengineering); LifeMoves, Menlo Park, CA.** Kelly was a Children Service Coordinator intern at Haven Family House, a shelter in the LifeMoves network that provides free, temporary housing for families in the Bay Area. She was a camp counselor for the site's children's summer camp, assisted with children's and teen's club for the residents of Haven, and helped on site as needed.
- **Zoey Hu, '24 (Feminist, Gender, and Sexuality Studies); Making the Right Connections, Inc., Los Angeles, CA.** Zoey was a TA for the summer school program at St. Vincent School in Los Angeles, CA. She helped implement curricula provided by Making the Right Connections, Inc, a nonprofit organization that focuses on gang prevention.
- **Abigail Maldonado, '25 (Undeclared); Wise Readers to Leaders, Los Angeles, CA.** Abigail interned as a literacy educator for Wise Readers to Leaders Los Angeles, a nonprofit flagship literacy program dedicated to closing the literacy achievement gap for nearly 500 K-8th grade students from Title 1 schools in the San Fernando Valley, Koreatown, Echo Park, Inglewood, and Watts. Through curriculum and enrichment activities she planned and led, Abigail, supported her classroom of 16 4th and 5th-grade scholars in building their literacy and leadership skills that will set them up for success in their future careers.
- **Ryan McJannet, '25 (Undeclared); California Education Partners, San Francisco, CA.** Ryan worked with California Education Partners, a nonprofit that facilitates relationships between school district practitioners and researchers to improve educational practices and outcomes. He developed a set of tweets to raise awareness about up and coming educational research and looked at survey data to develop recommendations for improving meeting format and practitioner-researcher relationships.
- **Skyley Mitchell, '25 (Undeclared); Making the Right Connections, Los Angeles, CA.** Skyley interned in Los Angeles for 9 weeks working under the organization "Making the Right Connections" which works with students who at high risk of working with gang and she worked at the partner school Saint Vincent Catholic School. She worked as a TA for the children and worked with administrators to prepare for the coming school year.
- **Daniel Mottes, '25 (Undeclared); Teens Exploring Technology, Los Angeles, CA.** Daniel interned at Teens Exploring Technology (TXT), a nonprofit organization that teaches underprivileged black and brown high schoolers how to code, utilize important UI/UX skills, start a company, and gain

important life skills. He coached a group of four high schoolers, from a cohort of 40, on how to build an app. Their app facilitated trading for collectors, and utilized blockchain technologies.

- **Buddy Noorlander, '24 (Undeclared); Greentrike, Tacoma, WA.** Buddy interned with Greentrike, a nonprofit organization that provides education and advocacy for children. He helped plan and run their annual summer camp.
- **Jerri Roper, '23 (Psychology); All Five School, Menlo Park, CA.** Jerri Anna interned at All Five School, a socioeconomically diverse pre-kindergarten program that focuses on play as a mechanism of learning. Throughout the internship, she was able to aid children in conflict resolution, confidence, and exploration.
- **Madeleine Salem, '24 (Symbolic Systems); Institute for Applied Behavior Analysis, Oakland, CA.** Madeleine served with the Institute for Applied Behavior Analysis, a social services organization that provides advanced and high quality services to people challenged by developmental disabilities. She helped develop and execute clinical, individualized, and data-driven behavior intervention plans for children with developmental disabilities within the organization.
- **Yara Sevilla, '23 (Computer Science); LifeMoves, Menlo Park, CA.** Yara interned with LifeMoves to run a summer camp for young students experiencing homelessness. She gave these young kids an opportunity to learn STEM related projects and practice reading over the summer.
- **Maraki Solomon, '25 (Undeclared); mEducation Alliance, Arlington, VA.** Maraki interned at mEducation Alliance, a nonprofit organization that implements effective Education Technology resources and practices globally. She created a 5 week STEAM curriculum and delivered trainings to middle and high school refugees.
